CERTIFICATIONS AND LICENSES

In 1990, Mike was awarded Certificates of Special Competence in Personal Injury Trial Law and Civil Trial Law by the Texas Board of Legal Specialization. He was recertified in 1995, 2000 and 2005. He is licensed to practice in all Texas State Courts and before the United States District Courts for the Eastern, Western, Southern and Northern Districts of Texas.
